Summary of development/review and consultation process

The review of the New Zealand Certificate in Financial Services (Level 5) [Ref: 2315] started in August 2023 with an advertisement of the qualification review. Ringa Hora Services Workforce Development Council consulted with the relevant stakeholders of the qualification. The stakeholders consisted of industry, associations, regulatory bodies, and education providers.

Consultation concluded that minor changes needed to be made for the qualification to remain fit for purpose and future-proof for the next 5 years.

Main changes resulting from the review process

The following were updated:

- Qualification Developer details, version, and review dates were updated.
- Closer alignment to the wording in the Code of Professional Conduct for Financial Advice Services was included in the Strategic Purpose Statement, Graduate Profile Outcomes, and in General Conditions for Programmes.
- Education Pathway, the New Zealand Certificate in Financial Services (Level 4) with strands in Banking, Family/Personal Budgeting, and Insurance [Ref: 2247] was removed as this qualification was discontinued December 2023.
- Graduate Profile Outcomes (GPO) context was added to some GPOs to better reflect the conditions under which the graduate will perform the outcome(s).
- GPO indicative credit weightings were rounded
- WDC Programme Endorsement considerations were included.
- Additional Transition Information was updated to include Standard Setting Body details.
