Summary of consultation process

Muka Tangata has extended the last date of entry to programmes leading to replaced qualifications [Ref: 3130-3135] from 31 December 2026 to 31 December 2027.

New resources and programmes are likely to take longer than usual to develop as they will be skill standards based.

Main changes resulting from the process

The replaced qualifications [Ref: 3130-3135] have been republished to extend the last date of entry to programmes leading to superseded versions of them from 31 December 2026 to 31 December 2027. The last date of assessment is unchanged.

The replacement qualifications [Ref: 5021-5022] have been republished to include information on the extended transition dates for the qualifications above.
