<p>A revision of the New Zealand Certificate in Ngā Toi (Level 3) was undertaken with Whakaruruhau to enable programme deliverers a choice for what would suit their delivery context and toi fields.</p> <p>The amendments will now enable programme deliverers to undertake one project brief or a selection of project briefs and focus on one Toi or a selection of Toi.</p> <p>Minor changes made to Graduate Profile Outcomes and an explanatory statement added to General conditions for programmes leading to the qualification.</p> <p>Consultation undertaken with Ngā Toi Whakaruruhau.</p>

Main changes resulting from the development/review process
<p>Graduate Profile Outcomes 1 & 3 updated to include <i>a project brief</i> for Ngā Toi rather than project briefs.</p> <p>Graduate Profile Outcome 4 updated to include <i>Ngā Toi</i> rather than <i>a range of</i> Ngā Toi.</p> <p>General conditions for programmes leading to the qualification – statement added that <i>programmes can include a single project brief or a selection of project briefs</i>.</p>
