Summary

Toitū te Waiora WDC identified the need for new skill standards to align with the New Zealand Certificate in Prisoner Management (Level 3) [Ref: 2658] graduate profile outcomes following a qualification review in 2023.

Review of the existing unit standards and development of skill standards took place between October 2024 and March 2025 in consultation with Department of Corrections, Serco, Te Pūkenga, Public Service Association, and the Corrections Association of NZ.

Wider consultation on these skill standards was sought through the Toitū te Waiora website in March 2025. No further revisions were required.

Main changes

- Six unit standards were reviewed, one of which has been set to expire without replacement.
- Six skill standards were developed.

Category C and D unit standards will expire on 31 December 2026.
