Range requirements include but are not limited to – air quality, water and

catchment protection, waste disposal and reduction.

## **Outcome 3**

Describe commercial factors influencing the development of organic horticulture in New Zealand.

## Performance criteria

3.1 Describe commercial factors influencing the viability of non-organic horticulture.

Range

factors include but are not limited to – cost of chemical remedies, development of chemical resistance in pests and diseases, cost of preventing and redressing chemical pollution problems, international competition for key export products and commodities.

3.2 Describe commercial factors promoting the development of organic horticulture operations in New Zealand.

Range

factors may include but are not limited to – increasing demand for certified organically grown produce, price premiums, long term reduction in production costs, and positive promotion of New Zealand horticulture industry; evidence of three factors is required.

3.3 Describe commercial factors restricting the development of organic horticulture operations in New Zealand.

Range

factors may include but are not limited to – relatively high cost of diverse plantings on small holdings, high cost of conversion to organic production, perceived non-commercial orientation and lack of market focus of organic industry, risk associated with high disease pressure on established non-resistant crops; evidence of three factors is required.

## **Outcome 4**

Describe key factors determining the viability of an organic horticulture venture.

## Performance criteria

4.1 Describe strategies for development of an aware and selective consumer market in terms of an organic horticulture venture.

Range strategies include but are not limited to – promotion, consumer education, crop choice.

4.2 Describe market requirements to be met in terms of production and provision of produce.

Range requirements include but are not limited to – quality, consistency of

supply, presentation, regulatory production standard met, crop

choice, demand, volume, timing.

4.3 Describe management strategies to be used in terms of growing certified organic products.

Range

strategies include but are not limited to – crop and cultivar selection and husbandry, commitment to certification fidelity, sustainable use of resources, use of professional guidance and support, management review, commitment to quality, regular review of strategies.
