- 1.3 Preview is carried out to ensure cargo is divided to enable manageable and efficient cargo operations.
- 1.4 Sufficient labour is allocated to carry out the operations safely.
- 1.5 The plan is confirmed for the commencement of operations.

Outcome 2

Carry out start up requirements.

Performance criteria

- 2.1 The availability of ship's gear and equipment for cargo operations is confirmed with ship's agent.
- 2.2 Required plant, gear, and equipment is checked and made available to carry out the operations.
- 2.3 The wharf area is confirmed as clear and ready for cargo operations.

Outcome 3

Brief workers about an upcoming cargo exchange.

Performance criteria

3.1 Information on hazards, cargo to be worked, requirements for personal protective equipment, emergency evacuation procedures, and any special requirements are communicated to workers.

Range examples of special requirements may include – out-of-gauge (OOG), reefers, break bulk, Class 1 dangerous goods.

Prepare a vessel for cargo operations.

Performance criteria

- 4.1 A pre-start check is carried out to ensure lighting, ventilation, and safe access and egress are available to facilitate safe and efficient cargo operations.
- 4.2 Safety lines are rigged around open hatches and accessways.
- 4.3 Securing equipment is available for operations and checked to be in good working order.
- 4.4 Dunnage if required, is available.
- 4.5 Stow plans and discharge and/or load plans are confirmed with ship.
