- 2 Definitions

Workplace procedures – refer to the written policies and procedures set by the client or employing organisation for the operation, maintenance, and storage of sports turf equipment.

In the context of this unit standard, *understanding* means that there should be evidence of a learner's thorough comprehension of a topic. A learner with a good understanding of a topic should have applied, or should be able to apply what they have learnt to a workplace situation and will be able to alter their practices to the different contexts they are applying their learning to. Assessors should be confident that the learner's understanding is embedded in their practices and behaviour.

Outcomes and performance criteria

Outcome 1

Demonstrate understanding of the function and operation of sports turf machinery and equipment.

Performance criteria

- 1.1 Describe horizontal and vertical mowing machinery in terms of its function and operation in the sports turf industry.
- Range machinery must include but is not limited to – reel, rotary, flail, cord trimmer, groomers, verticutters, dethatchers, groovers.
- 1.2 Describe turf conditioning and aeration equipment in terms of its function and operation in the sports turf industry.
- Range at least five of – spikers, slicers, verti-drain, corers, vibramoles, mole ploughs, water injection, borers, drillers, subsoilers, gas injectors, sprayable soil conditioners.
- 1.3 Describe seedbed cultivation equipment in terms of its function and operation in the sports turf industry.
- Range at least five of – rotary hoes, power harrows, harrows, discs, ploughs, spring tyne cultivators, scarifiers, groovers.
- 1.4 Describe spreaders, seeders and planters in terms of their function and operation in the sports turf industry.
- Range at least three of – drop spreaders, rotary spreaders, seed broadcasters, seed drills, spriggers.
- 1.5 Describe turf tractors and utility vehicles in terms of their function and operation in the sports turf industry.
- 1.6 Describe surface preparation machinery and equipment in terms of their function and operation in the sports turf industry.
- Range machinery and equipment must include but is not limited to – rollers, sweepers, line markers, turf cutters, water removers, covers.
- 1.7 Describe surface performance measurement equipment in terms of its function and operation in the sports turf industry.
- Range at least two of – clegg hammer, stimp meter, straight edge, ball roll devices.

Outcome 2

Select, set up and operate a range of sports turf machinery and equipment.

Range at least three of – mowing equipment, turf conditioning and aerating equipment, seedbed cultivation equipment, spreaders and seeders, surface preparation machinery and equipment.

Performance criteria

- 2.1 Select and set up equipment suitable for the site, ground conditions and sports turf specifications.
- 2.2 Carry out pre-operation checks.
 - Range pre-operation checks include but are not limited to – lubrication, fuel, water, tyres, freedom from obstructions, wear.
- 2.3 Operate machinery and equipment in a safe and controlled manner, and monitor for performance and efficiency.
- 2.4 Recognise and minimise risk to self, other people, and the environment.

Outcome 3

Service and store a range of sports turf machinery and equipment.

Performance criteria

- 3.1 Service and store machinery and equipment.
 - Range at least three of – mowing equipment, turf conditioning and aerating equipment, seedbed cultivation equipment, spreaders and seeders, surface preparation machinery and equipment.
