Job specifications refer to the standard requirements of the job being undertaken. Substrates may include – wood, fibre-reinforced composites, aluminium, steel; evidence of two substrates is required.

Outcomes and performance criteria

Outcome 1

Carry out preparation for marine exterior paint surfaces.

Performance criteria

- 1.1 Job specifications are obtained and verified in accordance with workplace policies and procedures.
 - Range specifications paint types, colours, combination and number of coats, drying times, standard of finish, standard of sanding profiles.

- 1.2 Protection is provided for existing equipment, fittings, furnishings, and surfaces in accordance with job specifications.
 - Range protection in situ, protection by removal and safe storage, electrical protection.
- 1.3 Work schedule for coating system is planned in accordance with job specifications and workplace policies and procedures.
 - Range plan work sequence and timing of activities.

Outcome 2

Prepare the previous coat for marine exterior paint surfaces.

Performance criteria

- 2.1 Previous coats are post-cured in accordance with job specifications and workplace policies and procedures.
- 2.2 Sanding between coats is carried out in accordance with job specifications.
- 2.3 Substrates are checked, and actions are taken if required to ensure the work area is kept free of possible surface contaminants.

Outcome 3

Apply build coats and finish coats for marine exterior paint surfaces.

Performance criteria

- 3.1 Coatings are applied in accordance with manufacturer's specifications for method of application, thinning, re-coat windows, and use of additives.
- 3.2 Number of coatings required are applied in accordance with job specifications and workplace policies and procedures.
- 3.3 Coated surfaces are checked in terms of standard of finish and level of gloss to ensure job specifications are met.
