Job specifications refer to the standard requirements of the job being undertaken.
Workplace policies and procedures refer to the documented procedures and policies providing guidelines of the tasks and activities carried out in the workplace. This typically includes relevant health and safety policies to manage risk in the workplace.
- 3 This unit standard applies to making boat covers, sail covers, fender pads, boat awnings, winch covers, binnacle and wheel covers, outboard covers or other associated marine covers and applications.

Outcomes and performance criteria

Outcome 1

Prepare to make covers.

Performance criteria

- 1.1 Customer requirements and job specifications are identified and verified in accordance with design specifications.

Range may include but is not limited to – protection, graphics, sponsorship.
- 1.2 Tools and equipment, and materials are prepared in accordance with job specifications.

- 1.3 Defects in fabric are identified and removed in accordance with workplace policies and procedures.
- 1.4 A template is made in accordance with job specifications.

Outcome 2

Make and fit covers.

Performance criteria

- 2.1 Material is laid out, measured, marked out, and cut, and all measurements are in accordance with design specifications and job specifications.
- 2.2 Material is stitched and assembled in accordance with job specifications and design specifications.
- 2.3 Fasteners are fitted to the cover in accordance with job specifications and design specifications.
- 2.4 Finished cover is checked and remedial action is taken if required to ensure design specifications and job specifications are met.
