- 3 Definitions
Accepted industry practice refers to approved codes of practice and standardised procedures accepted by the wider forestry industry as examples of best practice.
Forest harvesting refers to the felling and extraction of stems, landing operations, log making, and loading.
PPE refers to personal protective equipment and may include but is not limited to high-visibility, protective clothing, gloves, face and eye protection, safety helmet, footwear, hearing protection, and safety devices.

Worksite procedures refer to documented procedures used by the organisation carrying out the work and applicable to the tasks being carried out. They may include but are not limited to – standard operating procedures, site safety procedures, equipment operating procedures, quality assurance procedures, housekeeping standards, procedures to comply with legislative and local body requirements.

4 Assessment information

This unit standard must be assessed on-job.

All activities and evidence must meet worksite procedures and accepted industry practice.

Outcomes and performance criteria

Outcome 1

Explain health and safety requirements when trimming felled trees.

Performance criteria

- 1.1 The hazards and associated risks specific to trimming felled trees are identified and measures for controlling the risks are explained.

Range hazards may include but are not limited to – tree movement, branches/stem under tension, chainsaw kickback, proximity of extraction machine, ground conditions, slope of the ground, undergrowth, slash, continuous bending; evidence of five hazards is required.

- 1.2 The reason for on-going hazard and risk identification is explained.

- 1.3 Factors that may change hazards or introduce new hazards or risks are described.

Range weather, terrain, fatigue.

Outcome 2

Demonstrate knowledge of trimming felled trees for extraction.

Performance criteria

- 2.1 Trimming methods are described in terms of sequence of cuts.

Range lever-limbing method, large branches.

- 2.2 Rules specific to trimming are described.

Outcome 3

Trim felled trees for extraction from the forest.

Performance criteria

3.1 Select equipment to meet the requirements of the operation.

Range PPE, chainsaw, fuel storage, first aid.

3.2 Felled trees are assessed prior to and during trimming and heading.

Range hindrance, compression, tension, possible stem movement.

3.3 Trees are trimmed and headed in preparation for extraction.
