Accepted industry practice refers to approved codes of practice and standardised procedures accepted by the wider wood handling and distribution industry as examples of best practice.

Further processing can include pulp making, solid wood manufacturing, and wood panels manufacturing.

Workplace procedures refer to documented policies and procedures set by the organisation carrying out the work, and to documented or other directions provided to staff, and applicable to the tasks being carried out. They may include but are not limited to – standard operating procedures, site specific procedures, site safety procedures, equipment operating procedures, quality assurance procedures, product quality specifications, references, approved codes of practice, housekeeping standards, environmental considerations, on-site briefings, supervisor's instructions, and procedures to comply with legislative and local body requirements relevant to the wood handling and distribution sector.

3 Assessment information All activities and evidence must meet workplace procedures and accepted industry practice.

Outcomes and performance criteria

Outcome 1

Sort logs for further processing.

Performance criteria

1.1 Log grade is checked against grading marks and specifications and action is taken.

Range action – accept, reject, segregate, complete workplace documentation.

1.2 Logs are sorted.

Range grade, dimensions, species, age, condition, density.

1.3 Logs are moved to the relevant processing area at a rate that ensures safe operation.

Outcome 2

Load logs onto log decks.

Performance criteria

- 2.1 Logs are selected and loaded.
 - Range selection may include but is not limited to grade, dimensions, species, age, condition, density.
- 2.2 Selected logs are loaded in a manner that prevents overloading of the conveyor system and reduces the need for log unscrambling.
- 2.3 Measures are taken to reduce waste and prevent damage to equipment.

Range measures – loads centred on deck, reception deck chains operational before load delivered, load head returned to safe travelling position.

2.4 Rate of loading is matched with production requirements.
