*Company requirements* refers to instructions to staff on policy and procedures that are available in the workplace. These requirements may include – company policies and procedures, work instructions, product quality specifications and legislative requirements.

*Industry guidelines* refers to those practices and procedures commonly used as standard procedures to produce items of acceptable merchantable quality in the industrial textile fabrication industry such as related textbook descriptors.

*Manufacturer's information* refers to technical information for a machine or product detailing operation; installation and servicing procedures; manufacturer instructions; technical terms and descriptions; and detailed illustrations.

*Suitable tools and equipment* refer to industry approved tools and equipment that are recognised within the industry as being the most suited to complete the task in a professional and competent manner with due regard to safe working practices.

## Outcomes and performance criteria

### Outcome 1

Identify customer requirements and select pattern material in the industrial textile fabrication industry.

#### Performance criteria

1.1 Customer requirements are identified.

Range paper, fabric, wood, metal, combination of materials.

1.2 Pattern material is selected to suit job in hand.

Range number to be produced, complexity of shape, recurring order.

### Outcome 2

Mark out pattern shape in the industrial textile fabrication industry.

#### Performance criteria

2.1 Calculations are made to enable marking out of pattern in accordance with pattern specifications.

Range circular geometry, Pythagoras' theorem, regular and irregular areas, volumes of regular and irregular solids.

2.2 Required shape is developed in accordance with pattern specifications.

Range parallel line, radial line, triangulation, perpendiculars, arcs, angles, circles.

2.3 Required shape is marked out on the selected pattern material in accordance with pattern specifications.

Range pencil, felt pen, scribe, compass, straight edge, dividers.

### Outcome 3

Make up a pattern in the industrial textile fabrication industry.

#### Performance criteria

3.1 Pattern is fabricated to the required shape and finish.

Range adhesive, rivet, screw, nail, weld.

3.2 Pattern is marked to identify its purpose and layout directions.

3.3 Documentation is completed.
