

Title	Identify colour problems in the hair and explain colour correction

Purpose	<p>This unit standard is for people in the hairdressing industry who have knowledge of hair colour and wish to extend their colour knowledge to correcting unwanted colour in the hair.</p> <p>People credited with this unit standard are able to: demonstrate knowledge of hair colouring problems; identify colour problems and explain colour correction.</p>

Explanatory notes

- 1 Definition
Legislative requirements refer to the obligations of the employer and/or employee under the Health and Safety at Work Act 2015 and Health (Hairdressers) Regulations 1980.
- 2 In this unit standard all work must comply with legislative requirements and must ensure optimum hair condition and maximum client comfort at all times.
- 3 The colour change must be at least three levels, and a change of reflect must be demonstrated.
- 4 Assessment information
Evidence generated during assessment against this unit standard must be consistent with industry practice and knowledge. Such knowledge is available in reference texts, models, and other information-bearing media. No one textbook or other source of information is envisaged, as new approaches to the correction of colour problems in the hair are published regularly.

Evidence for assessment against outcomes 2 and 3 must include six case studies covering a range of colour problems and corrections. The case studies must include photographs of the client before and after and an explanation of the correction work.

Outcomes and evidence requirements

Outcome 1

Demonstrate knowledge of hair colouring problems.

Range incorrect colour reflect, incorrect level, banding, insufficient coverage, fading.

Evidence requirements

1.1 Hair colouring problems and their causes are described.

1.2 Corrective procedures for correcting hair colouring problems are described.

Outcome 2

Identify colour problems.

Evidence requirements

2.1 Client consultation is described.

Range incorrect colour depth and reflect, correction objective.

2.2 The results of hair and scalp analysis are explained in terms of the effect on the colour correction.

Range porosity, elasticity, texture, density, length, scalp.

2.3 The colour problem is identified.

Range incorrect level of colour and reflect, banding, insufficient coverage, fading.

2.4 The corrective techniques and products to be used are selected and explained.

2.5 A predisposition test for allergies is conducted in accordance with manufacturer's instructions.

2.6 Hair preparation is explained in accordance with manufacturer's instructions and selected technique.

Outcome 3

Explain colour correction.

Evidence requirements

3.1 All chemicals to be used are explained.

3.2 Manufacturer's instructions are identified.

3.3 The corrective colours and/or techniques are explained according to the manufacturer's instructions.

3.4 The colour correction process followed is explained.

- 3.5 The colour result is presented to show the colour correction has achieved the clients wishes.
