# Outcomes and performance criteria

#### **Outcome 1**

Strip beds for a commercial hospitality establishment.

#### Performance criteria

1.1 Beds are stripped with all linen and bed coverings removed within allocated timeframe.

Range linen and bed coverings may include but are not limited to – sheets, pillowcases, blankets, duvet.

1.2 Used linen and bed coverings are handled and stored in a safe and hygienic manner.

1.3 Any damaged linen or fouled bed coverings are identified and handled in a safe, and hygienic manner.

1.4 Any guest property found while stripping beds is handled appropriately.

## Outcome 2

Make beds for a commercial hospitality establishment.

#### Performance criteria

- 2.1 Correct type and quantity of linen and bed coverings are made available and kept clean, free from damage, and ready for use.
  - Range linen and bed coverings may include but are not limited to sheets, pillowcases, blankets, duvet.
- 2.2 Bed is made with correct linen and bed coverings within agreed timeframe.
