Outcome 1

Demonstrate knowledge of navigation tools used by a fire and emergency agency.

Range may include but are not limited to – map, compass, Global Positioning System and other electronic devices.

1.1 Map features are identified using a variety of maps.

Range features may include but are not limited to – scales, symbols, grid lines, contours, shading, legend.

1.2 An accurate position is fixed on a map using appropriate tools.

1.3 A map is oriented to match the features represented.

Outcome 2

Identify and report a location using maps.

Range

location may include but is not limited to – airfield, helibase or helipad, assembly area, emergency operations centre, incident control point, cordons, safe forward point, staging area, triage area.

Performance criteria

- 2.1 Own location is pinpointed to within 100 metres.
- 2.2 Locations of incident is reported, and facilities are pinpointed to within 100 metres.

Outcome 3

Select and use a route for navigation to an incident.

Performance criteria

- 3.1 Features on maps are identified to enable route selection through mixed terrain for on-foot, and vehicle.
- 3.2 Route distance and trip time are calculated.
- 3.3 Location are navigated via the selected route in accordance with the fire and emergency agency's best practice.
