Guidance Information

- 1 Assessment information
This unit standard may be assessed against off-job or on-job.
Job specifications and simple drawings must conform to current commercial industry practice.
All activities and performance criteria must be carried out in accordance with worksite policies and procedures.
- 2 Range
The drawings may be of items of furniture or furniture componentry.
Furniture or furniture componentry may include but are not limited to – bedside cabinets, tables, dining chairs, chair legs, table legs, desks, beds.
- 3 Definition
Worksite policies and procedures refer to documented policies and to documented or other directions provided to staff. These may include, but are not limited to, ways of managing health and safety, environmental considerations, quality, and production, and must conform to legislation. Examples include standard operating procedures, company health and safety plans, on-site briefings, and supervisor’s instructions. For the purposes of this unit standard worksite policies and procedures may also refer to the policies and procedures of an off-job training site.

Outcomes and performance criteria

Outcome 1

Establish job requirements for free-hand furniture drawings.

Performance criteria

1.1 Job specifications are obtained and interpreted.

Range item to sketch, shape, dimensions.

Outcome 2

Select and prepare equipment for free-hand furniture drawings.

Performance criteria

2.1 The equipment selected and prepared is checked for working order and quality required to produce the drawings required by job specifications.

Range equipment may include but is not limited to – drawing board, pencils, drawing paper, paper-fastening medium; quality required – undamaged surface of drawing board, clear and clean surface of drawing board, grade of pencil, unmarked paper.

Outcome 3

Construct free-hand drawings for use in furniture making.

Range a minimum of two two-dimensional drawings and two three-dimensional drawings is required.

Performance criteria

3.1 Two-dimensional drawings are constructed in accordance with job specifications.

Range includes – line quality, proportion.

3.2 Three-dimensional drawings are constructed in accordance with job specifications.

Range includes – line quality, proportion, shading, in perspective.

Outcome 4

Store drawings and equipment.

Performance criteria

4.1 Drawings are stored securely.

Range may include but is not limited to – drawer, folder, plastic envelope, tube.

4.2 Equipment and unused materials are stored safely and securely.

4.3 Work area and equipment are made clean, clear, and safe.
