<b>Recommended skills and knowledge</b>	Unit 15208, <i>Set and run the injection stretch-blow moulding production process</i> ; Unit 15211, <i>Service tooling for injection stretch-blow moulding</i> .

**Explanatory notes**

- 2 Definitions  
*Workplace procedures* – procedures used by the organisation carrying out the work and applicable to the tasks being carried out. Examples are – standard operating procedures, site safety procedures, equipment operating procedures, codes of practice, quality management practices and standards, procedures to comply with legislative and local body requirements.
- 3 This unit standard applies to either single stage or two stage injection stretch-blow moulding processes.
- 4 All evidence requirements must be performed in accordance with workplace procedures.

## Outcomes and evidence requirements

### Outcome 1

Remove, fit and set a preform injection mould for injection blow moulding.

Range may include product take-out devices.

### Evidence requirements

1.1 The moulding machine is prepared for a mould change.

1.2 Moulds are prepared for removal and fitting.

1.3 Mould changes are carried out.

1.4 Machine is set to job specification.

### Outcome 2

Remove, fit and set blow moulds for a container.

Range may include – blow timing devices, preform infeed parts, container outfeed parts.

### Evidence requirements

2.1 The machine is prepared for a mould change.

2.2 Moulds are prepared for removal and fitting.

2.3 Mould changes are carried out.

2.4 Machine is set to job specification.
