- 1.1 Hydraulic marine transmission is inspected for damage, faults or deterioration in accordance with workplace policies and procedures.
- 1.2 Pressure checks are carried out in accordance with workplace policies and procedures.

1.3 Transmission engine is tested in accordance with workplace policies and procedures.

1.4 Inspection report is prepared in accordance with workplace policies and procedures.

Repair a hydraulic marine transmission.

- 2.2 Transmission components are disassembled, inspected and cleaned in accordance with workplace policies and procedures.
- 2.3 Transmission faults are repaired in accordance with workplace policies and procedures and service information.
- 2.4 Transmission components are reassembled in accordance with workplace policies and procedures.
- 2.5 Transmission is refitted to the boat and functions are checked in accordance with workplace policies and procedures and service information.
