- 2 The last section, or 'Article 4,' has been omitted from some publications despite being seen by Māori as an important part of the Treaty. It is envisaged that this section be included in any analysis of the Treaty.
- 3 Participation and recognition of te Tiriti o Waitangi (te Tiriti) by hapū and iwi throughout the country varied considerably. Most of the contact with Pākehā up until the introduction of te Tiriti had occurred in the North. Te Tiriti was not signed in every area – indeed some hapū and iwi refused to sign the document.

- 4 It is envisaged that students be given the opportunity to develop ideas as to what the Treaty is and what is its purpose. It may be of use to study other treaties used for indigenous or other minority groups overseas.
- 5 For the purposes of this unit standard Te Tiriti o Waitangi (te Tiriti) refers to the Māori translation of the Treaty of Waitangi (the Treaty).
- 6 Recommend for entry: Unit 16048, *Describe the development and introduction of te Tiriti o Waitangi/ the Treaty of Waitangi*, or demonstrate equivalent skills or knowledge.

Outcomes and performance criteria

Outcome 1

Compare and contrast te Tiriti o Waitangi with the Treaty of Waitangi.

Performance criteria

- 1.1 Te Tiriti is described in terms of the translation process followed to write it.
- 1.2 Key sections, phrases and words of both te Tiriti and the Treaty are contrasted in terms of their differences in meaning.
- 1.3 The overall intent of the Treaty is compared with the overall intent of te Tiriti.

Outcome 2

Explain the texts of te Tiriti o Waitangi and the Treaty of Waitangi.

Performance criteria

- 2.1 The preambles of both versions are explained in terms of differences between the English and Māori language versions.
- 2.2 The intent of Articles 1, 2 and 3 of both versions are explained in terms of the differences between the two versions.
- 2.3 Article 4 of both versions are explained in terms of their importance to Māori.
