- 1.1 Identify the scientific name of the GreenshellTM mussel.
- 1.2 Describe the distinguishing features of the GreenshellTM mussel.

Range evidence is required for three features.

- 1.3 Describe the habitat of the Greenshell™ mussel.
- 1.4 Describe the geographical locations of GreenshellTM mussel marine farms.

Range evidence is required for three farm locations.

Outcome 2

2.2 Locate and identify the interior anatomical features of a Greenshell™ mussel.

Range foot, gills, labial palps, adductor muscle, gut, gonad, mantle.

2.3 Describe the function of each anatomical feature.

Range left and right shell, periostracum, byssus (beard), foot, gills, labial

palps, adductor muscle, gut, gonad, mantle.

2.4 Determine the sex of the Greenshell™ mussel.

Outcome 3

Demonstrate knowledge of the feeding, reproduction and life cycle of the GreenshellTM mussel.

Performance criteria

3.1 Describe what occurs at each stage of the life cycle of the GreenshellTM mussel.

Range stages include – egg, sperm, trochophore, veliger, spat, juvenile, adult.

3.2 Describe the feeding method and food source at each life cycle stage.

Range stages include – egg, sperm, trochophore, veliger, spat, juvenile, adult.

3.3 Describe what occurs at each stage of the reproductive cycle.

Range gonad development, natural triggers for spawning.

Demonstrate knowledge of the factors that impact on the growth of the Greenshell™ mussel.

Performance criteria

4.1 Describe methods of measuring the growth of the Greenshell™ mussel.

Range evidence of at least two methods is required

4.2 Describe factors that can affect the growth, and the impact of each factor on the growth of the GreenshellTM mussel.

Range growth factors may include but are not limited to – water

temperature, water quality, food quality, food availability, mussel

age, stress;

evidence of at least four factors is required.

Outcome 5

Demonstrate knowledge of abnormal features and/or behaviours that could indicate potential GreenshellTM mussel health issues.

Performance criteria

5.1 Describe abnormal features and/or behaviours that could indicate a potential health issue with the GreenshellTM mussel.

Range evidence of five abnormal features and/or behaviours is required.

5.2 Describe the action to take if abnormal features and/or behaviours are identified and the reasons why this action is important.

Range evidence of two reasons is required.
