Gather and document information required to prepare the statutory returns.

Range fish identification, fish processed state, conversion factors, unit weight, number of units, green weight, discarding rules, minimum fish legal size, accidental loss, fish to galley.

3.1 Gather and document information required to prepare the statutory returns in accordance with the Fisheries (Reporting) Regulations 2017.
