1 Definitions

Company requirements refer to instructions to staff on policy and procedures that are communicated in an oral or written form. These requirements must include legislation and safety requirements and may include but are not limited to, industry codes of practice and standards.

Manage systems in this unit standard may include but is not limited to the – development, implementation, application, monitoring, on-going improvement and audit of the systems to ensure legislative compliance with fisheries legislation.

2 Fisheries legislation requirements include but are not limited to the Fisheries Act 1996, associated regulations and subsequent amendments.

Manage the systems for seafood harvesting on a commercial fishing vessel.

Performance criteria

- 1.1 Systems are managed to ensure the harvesting of seafood is carried out in compliance with fisheries legislative requirements and company requirements.

Range target species, fishing method, fishing gear, vessel documentation, handling of accidental catch of protected species, catch effort, landing data and supporting documentation.

Outcome 2

Manage the systems for post harvest handling of seafood on a commercial fishing vessel.

Performance criteria

- 2.1 Systems are managed to ensure post harvest handling of the seafood is carried out in compliance with the fisheries legislative requirements and company requirements.

Outcome 3

Manage the systems for the recording and reporting of seafood harvesting on a commercial fishing vessel.

Performance criteria

- 3.1 Systems are managed to ensure the recording of the seafood harvest is carried out in compliance with the fisheries legislative requirements and company requirements.
- 3.2 Systems are managed to ensure the reporting of the seafood harvest is carried out in compliance with the fisheries legislative requirements and company requirements.

Outcome 4

Manage the systems for the update and implementation of fisheries legislation amendments.

Performance criteria

- 4.1 Systems are managed to ensure fisheries legislation amendments are received and appropriate changes made in accordance with company requirements.
- 4.2 Systems are managed to ensure fisheries legislation amendments are implemented on a commercial fishing vessel, in accordance with company requirements.
