Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of the purpose, types of bits and their functions, and select a bit for a horse for a specific activity, fit and remove.

Performance criteria

1.1 Explain the purpose and action of the bit on the horse in terms of its desired function.

Range tongue, bars of mouth, corners of mouth, roof of mouth, jaw, poll, chin groove.

- 1.2 Identify types of bits and describe their functions and suitability for a selected activity.
 - Range may include but is not limited to unjointed, single and double jointed, halfmoon, mullen mouth, fixed cheek, French snaffle, jointed snaffle, gag snaffle, double bridles (weymouth and bridoon), kimblewick, pelham, elevator, cherry roller, Dr Bristol, German snaffle (hollow mouth snaffle), dexter ring bit, anti-rearing bit; evidence of at least 10 bits is required.
- 1.3 Select a bit according to the action of the bit, the horse's stage of training, and regulatory requirements.
- 1.4 Fit bridles with bits, to ensure the fit is comfortable and remove from the horse without discomfort to the horse and in accordance with stable procedures.
- 1.5 Recognise resistance or evasion through pain or fear when been ridden, and action is taken to identify and remove or correct cause in accordance with stable procedures.
 - Range may include but is not limited to tongue over bit, 'above the bit' (horse puts head up), 'behind the bit' (horse tucks head in), bruised bars; evidence of one is required.

Outcome 2

Select auxiliaries and fit on the horse for a specific activity.

Performance criteria

- 2.1 Select auxiliaries suited to the activity of the horse and fit in a manner which is comfortable for the horse and fulfils required action.
 - Range may include but is not limited to nosebands; cavesson, drop, flash (hanoverian), grakle (crossed), kineton (puckle); martingales; standing, running, market harborough, irish; breastplates, crupper; evidence of three is required.

Outcome 3

Select and fit a saddle and saddle accessories suitable for a specific activity.

Performance criteria

- 3.1 Select saddle appropriate to the activity and the rider's requirements.
- 3.2 Fit saddle to contours of horse's back and the size of the rider.
- 3.3 Select girth appropriate to the activity, the type of saddle, and the rider's requirements.
 - Range may include but is not limited to web, leather, string, nylon, elastic; evidence of one is required.
- 3.4 Identify signs and behaviours of a sore back.
 - Range rearing, hypersensitivity, napping, bucking, bolting.
- 3.5 Identify causes of sore backs and rectify in accordance with the cause and stable procedures.
 - Range saddle fit, saddle cloth fit, rider experience, unevenly placed loads, poor conformation.

Outcome 4

Select back and saddle protection suitable for the horse and a specific activity.

Performance criteria

4.1 Select back pad appropriate to the activity, the type of saddle, and the rider's requirements.

Range may include but is not limited to – gel pad, key, foam; evidence of one is required.

4.2 Select saddle cloth and fit appropriate to the activity, the type of saddle, and the rider's requirements.
