## 2 Definitions

Environment refers to air, soil, water, flora and fauna.

Local is defined as a commonly recognised geographic region or area for example, Hawkes Bay, Napier, or Wairau Valley.

Short term refers to a time period of between 1 and 5 years, and *long term* refers to a time period of between 5 and 15 years.

Sustainable management is defined in the Resource Management Act 1991 as "the use, development and protection of natural and physical resources in a way, or at a rate, which enables people and communities to provide for their social, economic and cultural well-being for their health and safety while:

- a sustaining the potential of natural and physical resources to meet the reasonably foreseeable needs of future generations; and
- b safeguarding the life-supporting capacity of air, water, soil and ecosystems; and
- c avoiding, remedying, or mitigating any adverse effects on the environment."
