statutory agencies include – Police, Oranga Tamariki; processes may include but are not limited to – response timeframes, intervention pathways, feedback to the notifier, rights of the notifier, what happens to the reports, information given to families and whānau concerned.

consequences may include but are not limited to – charges laid, liability, safety of child and other children, appear as witness, coping with the personal feelings that result.
