### Guidance Information

- 1 All tasks must be carried out in accordance with enterprise procedures.
- 2 Definition  
*Enterprise procedures* – procedures used by the organisation carrying out the work and applicable to the tasks being carried out. Examples are – standard operating procedures, safety procedures, equipment operating procedures, codes of practice, quality management practices and standards, procedures to comply with legislative and local body requirements.

### Outcomes and performance criteria

#### Outcome 1

Prepare to load and unload, and arm and disarm pintle mounted aircraft guns.

#### Performance criteria

- 1.1 Task is determined by reviewing maintenance documentation and manuals.
- 1.2 Resources are obtained and checked for serviceability or status.  
 Range may include but is not limited to – tools, equipment, publications, signs, flags, ground support equipment and/or transporter.
- 1.3 Weapons are stored before loading and after unloading.

1.4 Aircraft is prepared for loading and unloading and arming and disarming.

Range aircraft positioned in authorised loading and unloading area, and arming and disarming area; distance between aircraft checked; safe headings checked; chocks fitted; bonding attached; warning devices fitted and removed; Hazards of Electromagnetic Radiation to Ordnance (HERO) precautions implemented; signs and/or flags positioned; ground support equipment and/or transporter positioned.

## Outcome 2

Load and unload pintle mounted aircraft guns.

### Performance criteria

2.1 Gun system is inspected.

Range guns, magazines, magazine chutes, electrical connectors.

2.2 Gun ammunition is loaded and unloaded.

## Outcome 3

Arm and disarm pintle mounted aircraft guns.

### Performance criteria

3.1 System is armed and disarmed.

Range clearance obtained from pilot, safety devices fitted and removed.

3.2 Jammed guns that could not be cleared by aircrew are cleared.

Range misfires, misfeeds, partial ejections.

## Outcome 4

Complete tasks related to the loading and unloading and arming and disarming of pintle mounted aircraft guns.

### Performance criteria

4.1 Defects are reported and documented.

Range armament system, guns, support equipment.

4.2 Resources are checked for serviceability and returned to service or storage.

Range may include but is not limited to – tools, equipment, publications, signs and/or flags, ground support equipment and/or transporter.

4.3 Leftover parts and materials are disposed of.

Range may include but is not limited to – serviceable, unserviceable, surplus, waste, scrap, hazardous.

4.4 Aircraft, system, and work area are left in a state enabling the next task to begin.

Range isolation tags attached or removed; external and internal warnings positioned and stowed; system switches and selectors set; power connected or disconnected; access panels closed, cleaned, tidied.
