Procedures must be consistent with current legislative requirements and manufacturer's recommendations or instructions where relevant.

Outcome 1

Demonstrate knowledge of lubricants and hydraulic fluids used for lubrication, and hydraulics of fish processing equipment and machinery.

Range MPI approved maintenance compounds; hydraulic oils.

Performance criteria

1.1 Describe the lubricant characteristics required for the lubrication points on the processing equipment and machinery on board.

Range MPI approved maintenance compound classification, temperature range.

1.2 Describe the hydraulic fluid characteristics required for the hydraulic systems on the processing equipment and machinery on board.

Range must include temperature range and one other characteristic.

Outcome 2

Lubricate a fish processing equipment and machinery.

Range trio skinner, conveyor, filleting machine, mincer/bone separator.

Performance criteria

2.1 Lubricate the equipment and machinery.

Outcome 3

Apply corrosion prevention coating to a fish processing equipment and machinery.

Performance criteria

3.1 Apply MPI approved coating to fish processing equipment and machinery.

Outcome 4

Maintain processing equipment and machinery hydraulic fluid levels.

Performance criteria

4.1 Maintain the correct hydraulic fluid levels in processing equipment and machinery.
