Portable power tools refer to electrically or pneumatically powered tools. These may include saws, planers, angle grinders, drill, sanders, grinders, nail guns, buffs, routers, electric scissors, electric rotary cutters, heat gun, hot knife, jig saw. Workplace policies and procedures refer to the documented procedures and policies for providing guidelines of the tasks and activities carried out in the workplace. This typically includes relevant health and safety requirements to manage risk in the workplace.

3 Assessment information

Evidence of five portable power tools is required.

Outcomes and performance criteria

Outcome 1

Select and use portable power tools to complete tasks in the marine or composites industry.

Performance criteria

- 1.1 Portable power tools are selected in accordance with job specification.
- 1.2 Portable power tools are used in accordance with manufacturer's recommendations and workplace policies and procedures.

Outcome 2

Care for portable power tools used in the marine or composites industry.

Performance criteria

- 2.1 Portable power tools which are unsafe, faulty, or in need of repair or maintenance are identified and corrective actions taken in accordance with workplace policies and procedures.
- 2.2 Portable power tools are cleaned, serviced, maintained, and stored in accordance with workplace policies and procedures.
