- 1.4 Mechanical fault checks are performed and reported.

Range may include but is not limited to – anti-slip mats, missing pins and

bolts, damage to spreader bar, damage to blades.

Operate hand points.

Performance criteria

- 2.1 Points are operated.
- 2.2 Points are visually checked to ensure blades are in correct position for required train movement.

Range facing, trailing.

Outcome 3

Demonstrate knowledge of risks associated with the operation of hand points.

Performance criteria

- 3.1 Risks and their implications for the operation of hand points are described.
- 3.2 The implication of direction of travel on the setting of hand points is explained.
