 - Land Transport (Road User) Rule 2004.
- 3 Definitions

Close supervision refers to the operation of a motorcycle under the active supervision of a supervisor who has the knowledge and experience to ensure that the rider is safe at all times.

Workplace procedures refer to the verbal or written instructions to staff on policies and procedures for use and safety of vehicles and machinery in the workplace.

For the purposes of this unit standard, *flat terrain* is defined as class A and B land under the Land Use Capability Classification, which comprises slopes between 0 - 7° (Flat to gently undulating to undulating terrain). 5 Assessment

- During assessment, manufacturer's recommendations and legislative requirements for the minimum age of a person driving a motorcycle must be complied with.
- The motorcycle must be specifically manufactured for rural workplace or off-road use. The motorcycle must have the following features – knobbly tyres, 2 wheels, gears.
- Candidates must be wearing a helmet suitable for the activity that either complies with the All Terrain Vehicle helmet standard (NZS 8600:2002) or is a motorcycle helmet of a standard specified in the Land Transport (Road User) Rule 2004.

Outcomes and performance criteria

Outcome 1

Prepare to ride a motorcycle on flat terrain.

Performance criteria

1.1 Identify suitability of the motorcycle for the anticipated activity in accordance with manufacturer's specifications and workplace procedures.

Range intended use, brakes, tyres, load capacities.

1.2 Carry out vehicle pre-ride safety check in accordance with manufacturer's specifications.

Range tyres, wheels, brakes, controls, lights, electrics, oil, fluids, fuel, chain, carry racks, freedom of movement of handlebars.

1.3 Wear personal protective equipment that is appropriate to the situation in accordance with manufacturers' recommendations.

Outcome 2

Ride a motorcycle on flat terrain.

Performance criteria

- 2.1 Plan the route in accordance with the terrain and weather conditions.
- 2.2 Control motorcycle at all times, maintaining traction, and minimising risk of damage to self, others and property.

Range steering, braking, gear selections, manoeuvring, change of surface.

2.3 Demonstrate active riding techniques.

Range weight transfer, stability, balance, body position, head and eye

position.

2.4 Demonstrate riding in situations with changes of surface.

Range changes of surface may include but not limited to firm ground,

muddy ground, loose gravel, pasture, undulating race, culvert

crossings;

evidence of three changes of surface is required.

- 2.5 Park motorcycle in a stable position, and report or fix any faults in accordance with workplace procedures.
- 2.6 Report and/or record accidents or near misses.
- 2.7 Follow instructions and consistently demonstrate safe riding that complies with safety requirements.
