# Outcomes and performance criteria

### Outcome 1

Evaluate when to harvest a crop.

### **Performance criteria**

- 1.1 Evaluate and report on crop condition in terms of crop maturity, withholding factors, and moisture content.
- 1.2 Evaluate paddock conditions in terms of their ability to withstand harvesting.
- 1.3 Evaluate weather in terms of the conditions forecast for the harvest period.

1.4 Assess the timing of harvest taking into account labour availability and expenses of crop harvesting.

## Outcome 2

Cut a crop under supervision.

### Performance criteria

- 2.1 Cut crop uniformly, without leaving uncut strips of grass or crop.
- 2.2 Check, adjust, and use machinery in accordance with crop conditions, and manufacturer's guidelines.

# Outcome 3

Harvest a crop under supervision.

Range pick up, thresh or direct head; evidence of one harvest technique is required.

### Performance criteria

- 3.1 Harvest crop at a time suitable for its intended use and environmental conditions.
- 3.2 Check, maintain, adjust, and use machinery in accordance with manufacturer's guidelines and end use of crop.
- 3.3 Harvest crop with minimal wastage or loss of quality.
