# 2 Definitions

Basic industrial rope access system provides access to carry out tasks at height or in other difficult-to-access situations.

Enterprise procedures – those practices and procedures that have been promulgated by the company or enterprise for use by their employees.

Hazards refer to occurrences, processes, substances or situations as determined by the organisation that are an actual or potential cause or source of harm associated with, but not limited to – process, activities, environment, equipment, materials, work organisation, site and facilities.

## 3 Training and assessment

People working towards, and being assessed against, this unit standard should note that work in the industrial rope access industry usually takes place at heights well above ground level and, therefore, requires a level of physical fitness and ability to work at heights.

# Outcomes and performance criteria

#### **Outcome 1**

Prepare site for setting up basic industrial rope access system.

## Performance criteria

- 1.1 Isolate the site in accordance with enterprise procedures.
- 1.2 Implement safety procedures, hazard management and signage in accordance with HSWA.
- 1.3 Set out exclusion zones in accordance with HSWA.

#### Outcome 2

Install basic industrial rope access system.

## Performance criteria

2.1 Tie knots in accordance with enterprise procedures.

Range bowline, figure eight, figure eight on the bight, threaded figure eight, clove hitch, tape knot, figure nine, fisherman's knot, alpine butterfly, prussic knot.

- 2.2 Install industrial rope access and rescue systems in accordance with planned hazard management and control measures.
- 2.3 Confirm that the industrial rope access systems are completed and are compliant with design and statutory requirements.
- 2.4 Clear the surplus equipment and tools from site in accordance with enterprise procedures.

## **Outcome 3**

Inspect basic industrial rope access system is safe to use.

# Performance criteria

3.1 Inspect and confirm the industrial rope access system as safe to use in accordance with statutory requirements.

# **Outcome 4**

Dismantle basic industrial rope access system.

## Performance criteria

- 4.1 Dismantle industrial rope access system in accordance with enterprise procedures.
- 4.2 Confirm the industrial rope access system is free of damage and wear.
- 4.3 Label, isolate, and log any damaged equipment in accordance with enterprise procedures.
- 4.4 Store equipment in accordance with enterprise procedures.
