## Outcome 3

Demonstrate knowledge of PPE in the scaffolding industry.

Range PPE includes but is not limited to – hard-hats, boots, clothing, eye protection, safety lines, belts, harness.

#### **Performance criteria**

- 3.1 Describe PPE to be carried by scaffolders in industry.
- 3.2 Explain use of PPE by scaffolders in industry.
- 3.3 Explain maintenance and inspection of PPE in industry.

#### Outcome 4

Interpret legislative requirements that relate to public protection in the scaffolding industry.

### Performance criteria

- 4.1 Interpret the legislative requirements for catch fans in terms of their relevance to health and safety in the scaffolding industry.
- 4.2 Interpret the legislative requirements for screening and containment sheeting in terms of their relevance to health and safety in the scaffolding industry.
- 4.3 Interpret the legislative requirements for safety nets in terms of their relevance to health and safety in the scaffolding industry.

## Outcome 5

Interpret and apply health and safety legislative requirements to the inspection of scaffolding equipment.

Range equipment – planks, fittings, components.

5.1 Interpret the equipment inspection requirements in terms of their relevance to health and safety and apply to the scaffolding work.
