- 3 Vineyard equipment may include tractor mounted forklifts, front end loader, towed equipment, three point linkage equipment, power take off driven equipment, equipment with hydraulics.

- 5 Definition *Workplace procedures* refers to policies and procedures on safety, operation, and production set down by the employer or host organisation.
- 6 Recommended unit for entry: Unit 19044, *Demonstrate knowledge of the legal requirements and hazards associated with tractor use*, or demonstrate equivalent knowledge and skills.

Outcome 1

Prepare vineyard equipment for operation.

Performance criteria

- 1.1 Identify equipment requirements in terms of site and crop characteristics.
- 1.2 Select and check equipment to confirm readiness for use.

Range safety standards and pre-start requirements are met, equipment is operational.

1.3 Set up equipment for use.

Outcome 2

Operate vineyard equipment.

Performance criteria

- 2.1 Operate equipment without damage to vines, equipment and property structures.
- 2.2 Monitor equipment performance to confirm performance is maintained within manufacturers specification.
- 2.3 Identify, rectify and/or report out of specification equipment performance.
- 2.4 Recognise and/or report problems and anomalies.

Outcome 3

Complete operation of vineyard equipment.

Performance criteria

- 3.1 Shut down equipment.
- 3.2 Clean, maintain and store equipment.
- 3.3 Collect, treat and dispose of, or recycle waste generated.

Outcome 4

Record and/or store vineyard equipment operation information in a retrievable format.

Performance criteria

- 4.1 Record and/or store workplace information.
 - Range may include standard operating procedures, specifications, production schedules or instructions, work notes, Material Safety Data Sheets, manufacturers' instructions, verbal direction from manager, supervisor or senior operator; evidence of two recording and/or storage formats is required.
