#### 3 Definitions

*Current industry good practice* means the range of actions currently accepted within the adventure and outdoor sector to manage the risk of harm to staff, participants, and others.

*Grade 1 terrain* is defined in the Mountain Bike New Zealand Mountain Biking Trail Grading and Code as fairly flat, wide, smooth track or gravel road.

# Outcomes and performance criteria

### Outcome 1

Demonstrate preparedness for mountain biking on grade 1 terrain.

### Performance criteria

- 1.1 Assemble required personal gear for the mountain bike ride.
  - Range may include but is not limited to clothing, footwear, food, hydration, helmet, personal medication.
- 1.2 Participate in basic directed safety checks before commencing ride.

Range includes but is not limited to – helmet fit and check, bike check.

### Outcome 2

Demonstrate riding skills on grade 1 terrain.

#### Performance criteria

- 2.1 Demonstrate safe and controlled riding skills on grade 1 terrain.
- 2.2 Follow instructions and safety guidelines, to maintain personal, group and other users' safety.
