# Outcome 1

Use tools and small equipment to complete amenity turf maintenance work.

# Performance criteria

1.1 Select and use tools and/or equipment to prune tree and shrub material impeding turf maintenance.

Range at least three tools or pieces of equipment from the following –

handsaws, loppers, long pruners, secateurs, hedge clippers.

1.2 Select and use tools and/or equipment to prepare turf edges for mowing, or to cut rough grass areas.

Range at least three tools or pieces of equipment from the following –

weed eaters with line or blade, edgers, rotary mower, reel mower,

edge shears.

1.3 Select and use tools and/or equipment to perform general maintenance tasks on turf areas.

Range at least three tools or pieces of equipment from the following -

rotary hoe, fork, roller, levelling screed, seed broadcaster, sprigger, temporary fence standard driver, mall or mallet, line

markers, hole cutters, pluggers.

1.4 Select and use tools and/or equipment to clean up after turf maintenance.

Range at least three tools or pieces of equipment from the following –

broom, shovel, leaf/grass vacuum or blower, rake, fork.

1.5 Complete work without damage to the tools or equipment.

### Outcome 2

Care for tools and small equipment used in amenity turf maintenance work.

#### Performance criteria

- 2.1 Care for tools and operation of equipment without damage to the tools and equipment.
- 2.2 Care for tools and equipment in a manner which maximises their working life and efficiency.

adjusting, lubricating, sharpening.
