- 1.3 Adjust an extraction device.

#### Outcome 2

Remove the foetus from the placenta in a meat processing operation.

- 2.1 Prepare foetus skin for incision.
- 2.2 Remove foetus from the placenta sac.
- 2.3 Drain blood from the foetal heart.

Extract foetal blood in a meat processing operation.

3.1 Extract blood from the foetus into collection bags.

Range extraction may include but is not limited to – incision, shut-down,

tube tying, bag removal, needle disposal;

evidence of three is required.

# **Outcome 4**

Secure and store extracted blood in a meat processing operation.

# Performance criteria

- 4.1 Remove and place bags in ice in accordance with organisational and legislative requirements.
- 4.2 Secure ice and/or blood and arrange transportation.
- 4.3 Dispose of condemned material in accordance with organisational and legislative requirements.
