# 1 Definitions

A construction site operation may form part of an organisation's activities or it may constitute a complete organisation;

On-site refers to a wide range of building and construction environments within which trade skills are applied;

Organisation may refer to any business engaging, controlling, or employing people in a building and construction environment.

- 2 All evidence and workplace practice must comply with codes of practice and documented site safety procedures for personal, product, and worksite safety.
- Descriptions of work practices must comply with the following: Building Act 2004; Building Regulations 1992; Construction Contracts Act 2002; Employment Relations Act 2000; Health and Safety in Employment Act 1992; Injury Prevention, Rehabilitation, and Compensation Act 2001; Resource Management Act (RMA) 1991; New Zealand Building Code and Approved Documents; New Zealand Standards.

# Outcomes and performance criteria

#### **Outcome 1**

Demonstrate knowledge of enactments relating to building construction site operations.

#### Performance criteria

- 1.1 Key requirements of legislation applying to on-site health and safety are described.
  - Range hazard identification, accident and incident investigation, accident and incident reporting, employer and employee duties, notifiable

works requirements, employee consultation procedures.

- 1.2 Key requirements of building construction legislation and regulations are described.
- 1.3 Key requirements of legislation applying to on-site employment and management of site personnel are described.
- 1.4 Key requirements of legislation applying to construction site contractual responsibilities are described.

#### Outcome 2

Demonstrate knowledge of the RMA as applicable to building construction site operations.

### Performance criteria

- 2.1 Description explains the impact of the RMA on building construction site operations.
- 2.2 Description identifies and explains Territorial Authorities' policies and plans to be complied with and consents to be acquired.
  - Range may include but is not limited to subdivision, building, water, soil, pollution, discharges, noise.
- 2.3 Description identifies and explains environmental values to be protected under the RMA.
  - Range may include but is not limited to water, soil, indigenous vegetation, air, Māori values.
- 2.4 Description explains building construction site operations in terms of compliance with the RMA.
  - Range consequences for non-compliance with the RMA, best practices for managing RMA compliance.

#### **Outcome 3**

Demonstrate knowledge of the Building Act 2004 and Building Regulations 1992 as applicable to building construction site operations.

# Performance criteria

- 3.1 Description explains the impact of the Building Act 2004 and Building Regulations 1992 on building construction site operations.
  - Range fire and safety protection, access and egress, energy efficiency, structural stability, moisture, safety of work force, demolition.
- 3.2 Description identifies and explains Territorial Authority requirements in terms of the Building Act 2004 and Building Regulations 1992.
- 3.3 Description explains the impact on building construction site operations of noncompliance with the Building Act 2004 and Building Regulations 1992.

#### **Outcome 4**

Demonstrate knowledge of the Employment Relations Act 2000 as applicable to building construction site operations.

# Performance criteria

4.1 Description explains the impact of the Employment Relations Act 2000 on building construction site operations.

## **Outcome 5**

Demonstrate knowledge of the Construction Contracts Act 2002 as applicable to building construction site operations.

5.1 Description explains the impact of the Construction Contracts Act 2002 on building construction site operations.
