- 2 Definition

- 3 Indigenous plant communities may include but are not limited to wetlands, grasslands, shrublands, coastal dunes, forests.

Outcomes and performance criteria

Outcome 1

Examine indigenous plant communities.

Performance criteria

1.1 Examine a plant community in terms of plant associations and the main plant species present.

Range may include but is not limited to – emergent, subcanopy, understorey, forest floor.

1.2 Describe the relationships between community members.

Range nutrient cycling, food chains, symbiosis, parasites, saprophytes.

- 1.3 Describe the process of plant succession, in relation to the plant community.
- 1.4 Identify the site conditions influencing a natural, or semi-natural, plant community.

1.5 Evaluate an example of a natural plant community and identify reason(s) for degradation or modification.

Outcome 2

Assess revegetation needs of a particular site.

Performance criteria

2.1 Analyse site conditions that may influence revegetation.

Range may include but is not limited to – soil, topography, climate, existing vegetation, animal effects, human effects.

2.2 Identify goals of revegetation.

Range may include but is not limited to – enhanced wildlife habitat, biodiversity, enhanced amenity values, water quality protection, retiring non-productive land, carbon-sequestration.

- 2.3 Identify site improvements needed.
 - Range may include but is not limited to weed control, animal control, shelter, perimeter, protection.
- 2.4 Compare the selected site with a less degraded site.
 - Range may include but is not limited to site conditions, improvements, limiting factors.
- 2.5 Consult with local authorities and community, as appropriate, on the revegetation programme.

Range may include but is not limited to – soil, climate, topography, plant and animal pests, human influences.

- 2.6 Identify plant species requirements and source of local provenance plants.
- 2.7 Identify possible revegetation strategies for the site.
 - Range may include but is not limited to planting, encouraging natural regeneration with minimal planting, maintenance and/or aftercare.

Outcome 3

Organise the plant material for revegetation.

Performance criteria

- 3.1 Formulate and document a revegetation strategy for site preparation, revegetation, and maintenance.
- 3.2 Organise the supply of plant material to suit revegetation plan.
 - Range may include but is not limited to provenance, propagation method, plant type, species, container type, supply logistics.

Outcome 4

Implement revegetation.

Performance criteria

- 4.1 Prepare the site for revegetation.
 - Range may include but is not limited to weed control, pest control, shelter, fencing, preparation of planting positions.
- 4.2 Position plants, and plant to facilitate plant survival.
