# Outcome 1

Plan dives to film, inspect, and collect data on a marine farm.

### Performance criteria

1.1 Explain the reasons for planning a dive to film, inspect, and collect data in accordance with company requirements and safety criteria.

Range safety focus of divers, legislation.

- 1.2 Explain potential hazards associated with the dives and the remedial actions.
  - Range hazards may include but are not limited to environmental hazards, marine organisms, limited visibility, disorientation, current strength, entanglement, strenuous activity, access to surface; evidence of four hazards is required; remedial actions include action taken to eliminate or minimise the hazard, such as decision not to dive, decision not to film, survey and collect data, access to safety equipment, communication plan, use of diver location device, emergency plan.
- 1.3 Complete dive plans in accordance with company requirements and safety criteria.
  - Range includes but is not limited to fitness and capability of the dive team, personnel numbers, surface conditions, diving platform and vantage points, in-water conditions, depth, equipment, bottom topography, communication signals; evidence of one plan per dive is required.

# Outcome 2

Carry out dives to film, inspect, and collect data on a marine farm.

### Performance criteria

- 2.1 Carry out pre-dive checks in accordance with company requirements and safety criteria.
- 2.2 Explain the procedure for in-water disentanglement of a diver in accordance with company requirements.

Range self, another diver.

- 2.3 Carry out dives to film, survey and collect data in accordance with the dive plans and company requirements.
- 2.4 Give, receive and respond to communication signals as agreed in the dive plans.

# Outcome 3

Record and report requirements for the dives.

# **Performance criteria**

3.1 Record and report requirements for dives in accordance with health and safety legislation and company requirements.

Range includes but is not limited to – personal logbook, company logbook, reporting schedule.
