3 Definitions

Basic roadmarking tasks are those which are carried out by a roadmarking assistant during daily roadmarking operations under general supervision. *Industry requirements* refer to relevant policies, processes, methodologies, industry codes of practice, site specific health and safety plans, standard operating procedures, site safety plans, quality plans, scope of works, work plans, traffic management plans, contract work programmes, job safety analysis, safe work method statements, job instructions, manufacturer's requirements, contract specifications, manuals, procedural documents, Waka Kotahi NZ Transport Agency specifications and guidelines.

Outcomes and performance criteria

Outcome 1

Perform basic tasks for roadmarking preparation.

Performance criteria

- 1.1 Roadmarking plant daily checks are completed.
 - Range may include but is not limited to fuel oil, water levels, tyre pressure; evidence of one daily check is required.
- 1.2 Roadmarking is prepared for in accordance with job instructions.

Range written and verbal communication, vehicle, loading, roadmarking materials, safety equipment, tools, check sheets; evidence of two types of preparations is required.

1.3 Roadmarking site is prepared in accordance with the Traffic Management Plan (TMP) and job instructions.

Range	signs, cones, vehicle placement;
	evidence of one preparation for the site is required.
