3 Definitions

Industry requirements refer to relevant policies, processes, methodologies, industry codes of practice, site specific health and safety plans, standard operating procedures, site safety plans, quality plans, scope of works, work plans, traffic management plans, contract work programmes, job safety analysis, safe work method statements, job instructions, manufacturer's requirements, contract specifications, manuals, procedural documents, Waka Kotahi New Zealand Transport Agency specifications and guidelines.

Simple roadmarking is roadmarking performed by an individual or small team on a single marking element. Situations include but are not limited to sections of longitudinal marking lines less than 150m and simple intersection markings such as a single give way or compulsory stop.

Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of specifications used for simple roadmarking.

Performance criteria

- 1.1 Categories of markings are described in accordance with the Waka Kotahi NZ Transport Agency specifications and guidelines.
- 1.2 Specifications for dimensional tolerances, application rates, material diary entries, traffic management, setting out, preparation of road surface, non-conforming markings, and remedial markings are stated in accordance with Waka Kotahi NZ Transport Agency specifications and guidelines.
- 1.3 The traffic management plan, contract quality plan, document control, and client requirements are described in terms of a specified job.

Outcome 2

Use references to locate and identify details of simple roadmarking requirements.

Performance criteria

- 2.1 Waka Kotahi NZ Transport Agency specifications and guidelines are used to locate and identify details of simple markings and raised pavement markers for roadmarking requirements.
- 2.2 Waka Kotahi NZ Transport Agency specifications and guidelines are used to identify details of roadmarking requirements.
- 2.3 Contract documents are used to locate and identify details of contract requirements.
