# Outcomes and performance criteria

## **Outcome 1**

Prepare the farrowing area for a new intake of sows.

#### Performance criteria

- 1.1 Prepare farrowing area for farrowing without damage to equipment and fittings.
- 1.2 Check equipment and fittings to ensure they are operational.
- 1.3 Carry out maintenance of equipment and fittings.

#### Outcome 2

Move sows to the farrowing area.

# Performance criteria

- 2.1 Check farrowing area is clean, dry and the drinkers and feeders are working.
- 2.2 Identify sows that are due to farrow in accordance with workplace procedures.
- 2.3 Treat sows as required in accordance with workplace procedures.
- 2.4 Move sows with minimal stress and without harm to animals or handlers.

#### Outcome 3

Monitor sows during farrowing.

#### Performance criteria

- 3.1 Identify imminent farrowing in accordance with workplace procedures.
- 3.2 Monitor farrowing progress in accordance with workplace procedures.
- 3.3 Check on a sow's udder in accordance with workplace procedures.
- 3.4 Keep records of sow monitoring in accordance with workplace procedures.

#### **Outcome 4**

Assist sows to farrow.

# Performance criteria

- 4.1 Observe sows and identify any problems during farrowing.
- 4.2 Carry out, when necessary, internal examinations of sows under hygienic conditions.
- 4.3 Keep records of assistance in accordance with workplace procedures.
