- 2 Definition
Workplace procedures refer to the policies and procedures set by the employer or organisation on workplace safety, procedures, and conduct.

Outcomes and performance criteria

Outcome 1

Carry out daily routine husbandry checks of grower pigs.

Performance criteria

- 1.1 Check and report on grower pigs in accordance with workplace procedures.
 Range behaviour, environment, water supply.
- 1.2 Check for behavioural and physical signs of ill-health in accordance with workplace procedures.
- 1.3 Identify and report signs of ill-health in growers in accordance with workplace procedures.

- 1.4 Take remedial action for identified problems in accordance with workplace procedures.
- 1.5 Keep records of routine husbandry checks in accordance with workplace procedures.

Outcome 2

Check and report on feed and water supplies, and feed grower pigs.

Performance criteria

- 2.1 Identify, report and remedy any water supply problems in accordance with workplace procedures.
- 2.2 Check feed storage bins for adequate supply of feed in accordance with workplace procedures.
- 2.3 Report feed supply shortages in accordance with workplace procedures.
- 2.4 Check hoppers have feed and troughs are clean in accordance with workplace procedures.
- 2.5 Remove stale and/or contaminated feed prior to dispensing fresh feed in accordance with workplace procedures.
- 2.6 Calibrate feeding equipment to dispense accurate feed levels in accordance with manufacturer's instructions.
- 2.7 Feed growers in accordance with the feed schedule.
- 2.8 Identify and take remedial actions for growers that are not eating in accordance with workplace procedures.
