Workplace procedures refer to the procedures and standards set by the client or employing organisation for landscape design, and must be consistent with manufacturer's guidelines and plans and specifications.

Outcomes and performance criteria

Outcome 1

Confirm site details and establish required protection.

Performance criteria

- 1.1 Confirm scope of works reflects drawings and report any variances.
- 1.2 Locate and confirm site boundaries details shown on drawings.
- 1.3 Locate and protect existing services from damage.
- 1.4 Locate and protect features to be retained from damage.

- 1.5 Confirm regulatory and compliance requirements applicable to the site and design.

Outcome 2

Establish liaison with parties affected by planned work.

Range client's neighbours, local authorities, contractors, site service providers.

Performance criteria

- 2.1 Advise affected parties of work that may affect them.
- 2.2 Consult and obtain agreement on programme of works and activity areas with relevant parties.

Outcome 3

Prepare the site for landscape work.

Performance criteria

- 3.1 Arrange site services required for completion of work.
- 3.2 Confirm location of, set out, and establish, site features.
- 3.3 Establish profiles and make final set out of site features.
- 3.4 Establish peg lines for contouring and features not requiring profiles.
- 3.5 Install or use safety warnings when work is accessible to the public.
- 3.6 Select, prepare, and use the appropriate hand and power tools, and equipment for the job.
- 3.7 Work safely around other people and machinery on site.
- 3.8 Remove unwanted material from the site.
