ISO 9001 refers to the ISO 9001 family of quality management documents for which companies gain specific accreditation.

Quality plan refers to a documented plan for quality assurance that may be contractspecific or based on a recognised quality assurance standard ISO 9001 series TQS series

Recorded, for this unit standard, means to indicate the construction set-out position on a plan or drawing.

Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of quality assurance for infrastructure works.

Performance criteria

- 1.1 Quality assurance for supplying a product or service relating to infrastructure works, and how this can be specified and met is explained.
- 1.2 The impact of individual performance on own and infrastructure works company's professional reputation is explained.
- 1.3 Procedures for detecting and reporting defects in infrastructure works plant, materials, and activities are identified and explained.

Outcome 2

Demonstrate knowledge of the requirements of a quality plan for infrastructure works.

Performance criteria

- 2.1 Hold points for a project are identified in the plan and actions required when those points are reached are explained.
- 2.2 Infrastructure works testing requirements are identified in the plan, and responsibilities for meeting them are explained.
- 2.3 Corrective actions for non-complying infrastructure works test results are explained in accordance with the quality plan.
- 2.4 Individual inputs and responsibilities for quality assurance and how they are met are determined from the quality plan.

Outcome 3

Complete quality assurance tests for infrastructure works.

Performance criteria

3.1 Quality assurance tests are actioned, recorded, and reported in accordance with own level of responsibility.
