Guidance Information

1 Assessment

Evidence generated for assessment against this standard must be verified by a person who has current expertise in the automotive glazing trades and has had the opportunity to regularly observe the candidate in the workplace carry out the removal and installation of glass in automotive mirrors.

All repairs must be completed in a commercially acceptable timeframe and workplace requirements.

2 Mirror replacement must be completed without injury to personnel or damage to products and equipment. Personal protective equipment must be used to meet regulatory and worksite requirements.

3 Definitions

Automotive mirrors – include internal rear vision mirror, external rear vision mirror. Job specification – refers to instructions to staff on policy and procedures which are documented in memo or manual format and are available in the workplace. These requirements include company specifications and procedures, work instructions, manufacturer's specifications, product quality specifications, legislative requirements.

Personal protective equipment – refers to anything used or worn by a person (including clothing) to minimise risks to the person's health and safety; air-supplied respiratory equipment.

Worksite requirements – refer to procedures used by the organisation carrying out the work and applicable to the tasks being carried out. They may include but are not limited to – standard operating procedures, safety procedures and guidelines, equipment operating procedures, codes of practice, quality management practices and standards, procedures to comply with legislative and local body requirements.

Outcomes and performance criteria

Outcome 1

Prepare to remove and replace glass in an automotive mirror.

Performance criteria

1.1 Determine the glass removal method, and materials and equipment requirements from the glass manufacturer and job specifications.

Range job specifications include – window size, shape and position; materials; Vehicle Inspection Requirements Manual (VIRM);

vehicle structural integrity.

- 1.2 Determine vehicle preparation requirements from the glass manufacturer and vehicle specifications and prepare the vehicle for removal of glass.
- 1.3 Select and prepare required personal protective equipment to meet health and safety requirements.
- 1.4 Identify the glass material specifications and confirm they meet the job specifications.
- 1.5 Identify procedures for minimising waste of materials.

Outcome 2

Manufacture and replace glass in an automotive mirror.

Performance criteria

2.1 Cut replacement glass to manufacture a mirror according to workplace requirements to meet job specification.

- 2.2 Prepare the mirror fitting for the replacement glass.
 - Range may include but is not limited to removing old glass, remove old

adhesive, remove high-spots, replacement area clean and free

from debris.

- 2.3 Replace the mirror glass in the vehicle fitting.
 - Range includes but is not limited to adhesive, shape and conform to

mirror shape.

- 2.4 Clean the mirror and prepare the vehicle for collection.
- 2.5 Provide warranty and safety information to the vehicle owner.
- 2.6 Complete any required documentation.

Outcome 3

Complete cleaning, storage, and maintenance requirements for replacing automotive mirror glass.

Performance criteria

- 3.1 Identify and store re-useable materials.
- 3.2 Remove and dispose of waste materials.
- 3.3 Inspect the work area for cleanliness and clear of tools and equipment.
- 3.4 Undertake equipment maintenance procedures.

Range check cutting tool, mirror stock is adequate for next job.

3.5 Clean and store tools, plant, and equipment used to replace automotive mirror glass.

Range plant includes – any machinery, vehicle, vessel, aircraft,

equipment (including personal protective equipment), appliance, container, implement, or tool; any component of any of those things; anything fitted or connected to any of those things; personal protective equipment includes – anything used or worn by a person (including clothing) to minimise risks to the person's

health and safety; air-supplied respiratory equipment.
