- 2 Definition

Workplace procedures refer to organisation policies and procedures that are documented in memo, electronic, or manual format and available in the workplace. They may include but are not limited to – standard operating procedures, site specific procedures, site safety procedures, equipment operating procedures, quality assurance procedures, product quality specifications, manufacturer's requirements, references, approved codes of practice, housekeeping standards, environmental considerations, on-site briefings, supervisor's instructions, and procedures to comply with legislative and local body requirements relevant to the print sector.

- 3 It is recommended that people hold credits for Unit 341, *Carry out routine and preventive maintenance common to the print industry*, before being assessed against this unit standard.

4 Assessment information

Evidence presented for assessment against this unit standard must be consistent with safe working practices and be in accordance with applicable service information, workplace procedures and legislative requirements.

Outcomes and performance criteria

Outcome 1

Adjust the various systems of the printing press and associated auxiliary equipment.

Range systems include – infeed system, printing unit, register system, delivery system, web guides;
auxiliary equipment may include – numbering unit, encoding unit, punching unit, creasing unit, diecutting unit, perforating unit, foil stamping, cold foiling (dieless), waxing, laminating, slitter.

Performance criteria

- 1.1 Identify printing press and auxiliary equipment adjustments required for optimum operation while carrying out inspection and maintenance.
- 1.2 Carry out or report adjustments and repairs required for optimum operation of the press and auxiliary equipment.

Outcome 2

Adjust and calibrate measuring gauges and instruments.

Performance criteria

- 2.1 Identify required adjustments to measuring gauges and instruments while carrying out inspection and maintenance.
- 2.2 Check and adjust calibration as necessary to maintain accurate production standards.
