2 Definition

Records of Title prove the ownership of land and rights and restrictions that apply to land. They are previously referred to as computer register or Certificates of Title; renamed in the Land Transfer Act 2017.

Explain property law terminology.

Performance criteria

- 1.1 Explain property law terminology as they apply to real estate practice.
 - Range includes but is not limited to Record of Title, equitable interest, indefeasibility, lease, legal interest, licence, ownership, personal property, possession, real property, registered interest, title search, types of title.

Outcome 2

Identify Records of Titles and explain registered interests.

Performance criteria

- 2.1 Identify Records of Title and explain their tenure consistent with applicable legislation.
 - Range includes but is not limited to company share, cross lease, free hold (fee simple), leasehold, unit title (stratum estate).
- 2.2 Explain interests that may be registered on the Record of Title consistent with applicable legislation.
 - Range interests include but are not limited to consent notices, fencing covenants, fencing agreements, land covenants, limited as to parcels, limited as to title, caveats, easements, mortgages.

Outcome 3

Explain the law relating to the ownership and transfer of land.

Performance criteria

- 3.1 Explain land ownership in New Zealand in terms of the Torrens system.
 - Range includes but is not limited to Record of Title, registration of title, indefeasibility of title.
- 3.2 Explain forms of land transfer consistent with applicable legislation.
 - Range includes but is not limited to sale and purchase, will, gift, trust, operation of law, assignment of lease, acquisition by the Crown.
- 3.3 Explain the land transfer process consistent with applicable legislation.
 - Range includes but is not limited to sale and purchase, procedure for the transfer of land, information recorded in the land transfer system, creation of other interests.

Outcome 4

Explain forms of co-ownership of land.

Performance criteria

4.1 Explain forms of co-ownership of land consistent with applicable legislation.

Range includes but is not limited to – joint tenancy, tenancy in common, Māori ownership of land, company, trust.
