## 3 Definitions

Changeover refers to the replacement of parts, and adjustment of: the position of components; system pressures; tensions; and function timing.

Worksite policies and procedures refer to documented policies and to documented or other directions provided to staff. These include, but are not limited to, ways of managing health and safety, environmental considerations, quality, and production, and must conform to legislation. Examples include standard operating procedures, company health and safety plans, on-site briefings, and supervisor's instructions.

# **Outcomes and performance criteria**

#### **Outcome 1**

Explain the fundamentals of the changeover of the rotary die on a diaper machine.

## Performance criteria

- 1.1 The purpose and operational capabilities of the rotary die are described in accordance with worksite policies and procedures.
- 1.2 The operation of changeover equipment and tooling is described in accordance with worksite policies and procedures.
- 1.3 Hazards associated with the changeover of the rotary die are identified and the role of protective equipment and safety features is explained in accordance with worksite policies and procedures.

Range

safety features may include but are not limited to – energy isolation procedures, lockouts, emergency stops, guards. hazards may include but are not limited to – in running nips, lifting objects with cranes, moving parts, automated processes, sharp edges, chemicals, noise, compressed air.

1.4 The consequences of non-conformance with worksite operating procedures are described in accordance with worksite policies and procedures.

#### Outcome 2

Changeover the rotary die on a diaper machine.

#### Performance criteria

2.1 Safe work practices are demonstrated in accordance with worksite policies and procedures and legal requirements.

Range

practices may include but are not limited to – energy isolation procedures, lock outs, emergency stops, machine guarding, wearing of appropriate safety equipment.

- 2.2 The rotary die is changed over in accordance with worksite policies and procedures.
- 2.3 Inspection of plant components identifies wear or damage and corrective action is taken in accordance with worksite policies and procedures.
- 2.4 Tools and removed components are stored in accordance with worksite policies and procedures.
- 2.5 Monitoring of performance, and adjustment of control parameters, enables productivity and quality to be maintained in accordance with worksite policies and procedures.
- 2.6 The rotary die and work area are cleaned in accordance with worksite policies and procedures.
